If you want your medical to be considered for coverage under the Workers' Compensation Program, it is required that you seek medical care from one of CSU's Authorized Treating Physicians (ATPs). These medical providers specialize in on-the-job injuries, the Workers' Compensation process, and work with us to ensure that you have the best possible care.

After each appointment, provide a copy of your medical status report to your supervisor.

Please note: If you seek initial treatment from the Emergency Room, Urgent Care, or other provider, <u>YOU</u> will need to provide them with your entire claim billing information; otherwise, you will billed. If you receive a bill for your Workers' Compensation claim, <u>YOU</u> will need to reach out to the billing department of that provider. The payment of bills outside of an ATP will be dependent on your claim being compensable. One of the medical providers designated above must provide <u>all</u> follow-up care. If follow-up care is with an *unauthorized* medical provider, the employee will be responsible for payment for said treatment(s) and related costs.
